

## Remodel It Forward Official Rules And Regulations

### CONSUMER DISCLOSURE/REMODEL IT FORWARD AWARD RULES:

YOU HAVE NOT YET WON. NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN AND YOU DO NOT HAVE TO SUBMIT TO A SALES PRESENTATION. PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Tri-State Windows, Siding And Roofing ("Sponsor") will award two giveaways during the giveaway period. The giveaway period begins May 1, 2020 and ends October 15, 2020. Sponsor's computer shall be the official time-keeping device for this promotion. Three semifinalists will be selected through a third party selection group from all the entry submissions; one set of semifinalists for the roofing giveaway and one group of semifinalists for the siding giveaway. The odds of winning a giveaway is determined by the number of entries received prior to September 30, 2020. Sponsor reserves the right at its sole discretion to suspend, modify, or terminate this promotion without notice at any time. No more than one (1) entry per household is allowed and giveaways are limited to one (1) giveaway per household. Between September 30, 2020 and Midnight of October 14, 2020 the community at large will have the opportunity to vote on the semifinalists for each giveaway. 2. Each Giveaway winner will be notified by e-mail or by telephone within three (3) business days of the drawing in which the Giveaway winner is selected. Sponsor shall make three (3) attempts to notify each of the Giveaway winners in this manner within three (3) business days of the drawing. If either of the Giveaway winners still has not been contacted and notified after these three (3) attempts, then Sponsor will send a fourth and final notification attempt via certified mail, return receipt requested, to the address of the Giveaway winner indicated on the winning entry within fourteen

(14) days of the drawing. The Second Winner will receive new, professionally-installed, vinyl siding, in accordance with applicable codes, manufactured by CertainTeed, up to a value of \$15,000. The maximum retail value of the New Siding is \$15,000. The maximum retail value includes the cost of labor and material. Installation must be provided by Sponsor's personnel or designee. Sponsor's personnel or designee shall obtain any required permit to perform the installation. Any costs in excess of the stated retail value for the Giveaway shall be the sole and exclusive responsibility of the Giveaway winner. All expenses not specifically provided for are the sole responsibility of the Giveaway winner. The address listed on each entry form must be an eligible address as provided for in Section 5 of these Official Giveaway Rules and must be the address where any product will be installed or where any services are rendered. Any arbitration proceeding and any award or verdict shall remain confidential between the parties and shall not be made public.
